The **scope of work** will be as per the specification mentioned below:

1. Purchasing and installation of the following Electrical Equipments along with electric point connection:
 - i) Sub-Meter
 - ii) Long arm ceiling fans – 20 nos.
 - iii) Glass Well Lights (40 W) – 16 nos.
 - iv) 24 W Led Batten Light for office – 3 pcs
 - v) Wall mounted fan for office – 2 pcs
 - vi) Exhaust fan for toilet – 1 pc
 - vii) 16W LeD surface panel light for toilet
 - viii) MCB – as per requirements
 - ix) One Air Conditioner – 2 Ton in the office area
 - x) Adequate switch board and switches (modular)
2. Installation of electrical points only (in Godown):
 - i) Two 16 Amp points for installation of 2 Box Strapping Machine
3. Installation of Electrical Points only (in Office Area)
 - i) Four 16 Amp points for installation of 2 computers with its peripherals
 - ii) Two 16 Amp points for Electric Kettle

The following Terms and Conditions may kindly be noted by the bidding vendor:

1. Only Sealed quotations will be accepted, which should be super-scribed with “Quotation for electrical equipment and electrical points in Godown 5E, CWC Garden Reach”
2. The vendor shall perform any other related or incidental work assigned by the Organization related to electric points, with no extra cost to the Organization.
3. The quoted rate should be inclusive of GST and all other charges.
4. Vendors/agencies having GST Number, Trade License, PAN, Income Tax Certificate of last three years and undertaking with regard to blacklisting/ non-debarment (format enclosed) may submit their quotations with copy of each document duly self-certified and a list of previous experience with details of previous works done. For any clarification kindly contact our office.
5. The sealed quotation will be opened on 01 June 2026 at 11:00 AM in the conference room in the first floor of the office. The bidders are requested to be physically present to see the quotation opening process.
6. No advance payment(s) will be paid. Payment will be made through PFMS on submission of the bill upon successful completion of the work subject to certification/recommendation by the Committee constituted for the purpose.
7. Tenderers shall not be permitted to withdraw offer or modify the terms and conditions thereof at any time during the process of finalizing the award of work/contract/job.
8. In case of breach of any of terms and conditions mentioned above, the Competent Authority of Sahitya Akademi will have the right to cancel the work order without assigning any reason therefor and nothing will be payable by the Sahitya Akademi in that event.
9. The agreement shall be deemed to have been concluded in the National Capital Territory of Delhi and all obligations hereunder shall be deemed to be located at the NCT of Delhi and the Court within NCT of Delhi will have jurisdiction to the exclusion of all other Courts.
